## **Year 6 Residential Trip 26<sup>th</sup>– 28<sup>th</sup> June 2024**

We have made a provisional booking for Year 6 children to participate in a residential trip to Bawdsey Manor on the Suffolk coast in June 2024. We will be travelling by coach and the visit will be for 3 days and 2 nights from Wednesday 26<sup>th</sup> June and includes:
